TCLA By-Laws

A TCLA meeting was held to present and vote on a TCLA By-Laws revision on February 28th. The revised by-laws were approved and go into effect immediately.

A copy of the by-law revisions were mailed out January 14th as well as sent via emailed. As required by the current by-laws, a 45-day is notice is required to membership. The main purpose of the TCLA By-Laws revision is to restructure the TCLA Board of Directors. The TCLA Board members were the elected advisory board members of the three business districts of Camden, Miller, and Morgan County. The new TCLA Board will be comprised of three members, one from each county of Camden, Miller, and Morgan.

In-person voting will take place at the Miller County Business District Annual Meeting on Thursday, March 24, 2022, from 9:00 a.m. to 11:00 a.m. The annual meeting will take place at The Lodge at Port Arrowhead located at 3080 Bagnell Dam Blvd., Lake Ozark, MO.

The Business District of Morgan County has accepted nominations to fill: one (1) Morgan Small (1-50) expired seat. Lodging Tax Collection Update

Visitors are really enjoying our little piece of paradise! We are through the first half of the fiscal year up 15.9% in lodging tax over that same time period last year, for all three counties combined. Group and Convention business made a strong come back in the fall and winter months. Here is the breakdown by County and property size: Camden Small up 1.27%, Camden Medium up 28%. Camden Large up 32.4%, Miller Small up 1.81%, Miller Medium is down 23.86%, and Morgan Small up 38.29%.

Currently the record for the Largest Boat Parade is held in Malaysia with 1,180 boats. Our goal is to beat this record to not only bring the World Record to the United States but to Lake of the Ozarks. We attempted to break the record in 2021 and fell a little short. We have learned from the experience and made some adjustments. We are ready to bring this record home to the Lake!
